# Cyber-bullying and social media

The way in which some students communicate with each other through social media platforms, particularly SnapChat, is causing problems at school. During this half term, the safeguarding team have seen some of these messages and we have been shocked by the language being used in the messages exchanged. Although this is taking place outside school, problems are occurring inside school that are causing upset to students and making them to feel unsafe amongst their peers.

We would like to request that all parents/carers talk to their child/children about how to behave respectfully towards their peers online. We would also like to suggest that all parents/carers, if this is not already in place, check some of their child's/children's messages to ascertain how appropriate communication is between their peers.

# Vaping: High lead and nickel found in illegal vapes

Further to the recent news headlines about the contents of vapes ceased in a secondary school in Kidderminster, we urge all parents/carers to remain vigilant for these types of items. Disposable vapes are often branded and marketed in ways that make them very appealing to teenagers which is contributing to what has been described as a new pandemic. ## Indecent images/sexting and the law

The safeguarding team often deals with concerns raised by staff, students and parents/carers about indecent images/sexting. Despite educational inputs by the College, some students continue to take risks related to indecent images/sexting. From our conversations with parents/carers, there is some uncertainty regarding indecent images/sexting and the law therefore we would like to offer the following clarity:

It is an offence to *make, distribute, possess or show* any indecent images of anyone aged under 18, even if the content was created with the consent of that young person. Please note that indecent imagery does not always mean nudity, it can also be semi-nude sexual posing (e.g. displaying genitals and/or breasts or overtly sexual images of young people in their underwear) and/or touching themselves in a sexual way. Young people refer to indecent images/sexting as: *dic pics*; *pics* and *nudes*.
