E-safety

Over the summer break, we expect students will spend more time online both browsing and communicating with their peers. Unfortunately, from our experience at school, we know that much damage can be done to students' self esteem through online communication platforms and more specifically, Snapchat.

The most common things we deal with are: exclusion from group chats and therefore invitations to join peers socially; inappropriate comments which can include offensive, prejudicial language (for example: homophobic; racist and/or sexist). We appreciate that it can often be difficult as a parent/carer to regularly check social media exchanges (particularly Snapchat) therefore we recommend talking to children about the 4Cs of e-safety: conduct; contact; content and commerce. Fire, river and road safety

During assemblies this week we have advised students to be safe over the summer break however we also realise that young people, particularly under significant peer pressure, can engage in risk taking behaviours. We know that most parents and carers regularly talk to their children about mitigation of risk. From our experiences at school, we often see young people, plugged into their devices listening to music, unaware of what is going on around them in terms of bikes, buses and other vehicles more generally.

Furthermore, we are aware of how exciting a day out alongside the river is for young people but also the side effects of swimming in (for example, the river Cam) water with sewage pollution and potentially debris on the riverbed.

Safeguarding is everyone's responsibility

Please remember that anyone can make a referral to social care with a safeguarding concern. Ideally, this should be done via the county that the referee lives in. If this is unknown, the county of the referrer should be used.

Indecent images/sexting and the law

This term, we have experienced some incidents of sexting amongst our younger students (for example in Year 7 and Year 8). From our conversations with students, there is some uncertainty regarding indecent images/sexting and the law therefore we would like to further re-iterate (from our Summer 1, Safeguarding Bulletin that: It is an offence to *make*, *distribute*, *possess* or *show* any indecent images of anyone aged under 18, even if the content was created with the consent of that young person. Please note that indecent imagery does not always mean nudity, it can also be semi-nude sexual posing (e.g. displaying genitals and/or breasts or overtly sexual images of young people in their underwear) and/or touching themselves in a sexual way. Young people refer to indecent images/sexting as: *dic pics*; *pics* and *nudes*. Please click here for a useful resource to support young people and their families with this topic. Please be reassured that the police seldomly wish to criminalise young people about this subject matter, it is more common that an educational approach is adopted to inform future decision making.
